STATEMENT A
Mission and Objectives

Spirit of America's mission is to support the safety and success of Americans serving abroad by helping them assist local people, and by connecting them to the capabilities, resources and goodwill of the American people and private sector.

What We Do

In 2015, Spirit of America completed 70 projects in 24 countries, accomplishing humanitarian, economic, and security objectives in direct response to critical local needs identified by US troops and diplomats.

The bulk of our support was focused on three priority areas: Iraq, Niger, and Ukraine.

Iraq/Kurdistan

Last year, Spirit of America expanded its support for the counter-Islamic State mission in northern Iraq. We provided targeted humanitarian assistance to meet the basic needs of refugees who fled the conflict. We also provided materiel support – metal detectors, first aid kits, and more – to help the Kurdish Peshmerga forces being advised by US Special Operations Forces secure their country.

Niger

In Niger, we worked with US teams to confront two threats to regional and global security: al Qaeda and related terror groups in the northwestern region of the country, and Boko Haram along the southern border with Nigeria. In northwest Niger, we provided veterinary scholarships and livestock vaccination campaign support to improve food security, provide opportunities for vulnerable youth, and reduce susceptibility to extremist influence. In southern Niger, we provided materiel support – again, metal detectors, first aid kits, and more – to help US-backed security forces protect local communities. And, we funded a regional summit that brought community leaders together to develop a unified approach to countering Boko Haram.

Ukraine

We also established programming in Ukraine designed to counter the Russian-backed separatist threat and help restore peace and sovereignty to a strategic partner of the United States. We provided first aid kits to develop the trauma capabilities of Ukrainian soldiers being trained by US troops. And, we initiated a radio project to counter Russian propaganda by meeting the basic information and entertainment needs of Ukrainian soldiers on the front lines.
